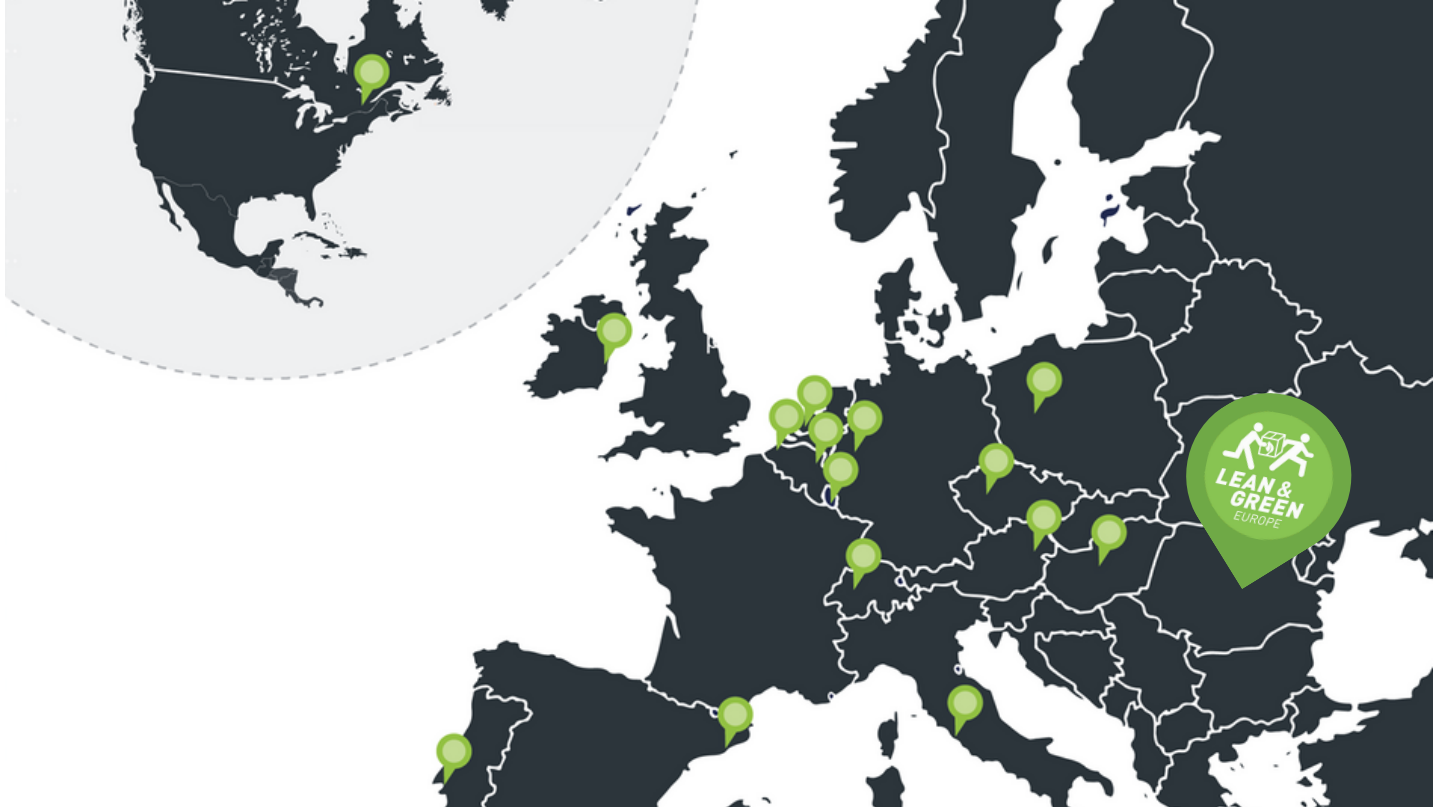

Pilot project proposal for Lean & Green Romania

Introduction

As a long time ambassador for the Lean & Green program in Europe CHEP reached out to Lean & Green to explore the possibility of starting the program in Romania.

This led to a series of round table sessions joined by several companies with Romanian logistical activities. Also multiple National Partners of Lean & Green joined the conversation to support the development of the program.

GS1 Romania also gladly joined the sessions out of interest to become National Partner for Lean & Green in Romania.

Objectives

The pilot project has two main objectives it aims to achieve.

Firstly to start the Lean & Green program in Romania with local collaboration.

The pilot provides the new National Partner for Lean & Green (GS1 Romania) the best start possible by the experience gained through the pilot and the first potential participants by the end of the pilot project.

Secondly to make the first group of companies familiar with the Lean & Green program in Romania and support them in the completion of the Lean & Green Action plan and potential Star Awards.

As ambassadors to the program they together could form the start of a community for sustainable logistics, sharing knowledge and experience.

Possibly some might join the Steering group that shall be formed once Lean & Green Romania is established.

Pilot: Star 1 Action plan

Company description

A description of the core logistical activities of the company.

Scope

Decide what percentage of the total outbound volume is taken in to the carbon reduction analysis.

Data

Collect and analyse the data of total volumes and emissions (fuel) data from recent years.

Reduction measures and projects

Describe the measures and projects are completed in the past, still active and/or planned projects for optimization and carbon reduction . (Three projects per Star level) if none available we will provide assistance within the pilot to define/plan/implement)

Review

After finishing the Action plan it will be reviewed by the Lean & Green program.

Audit

The final step before recognition is the external verification of the data analysis.

Service and support

The support offered by Lean & Green Europe during the pilot project includes:

- 4x Monthly Support sessions with the pilot group.
- 4x 1 hour per month support call for every participant.
- Review of the Action Plan

And of course we will share all the tips and tricks we have available to make this pilot a success for all the participating companies.

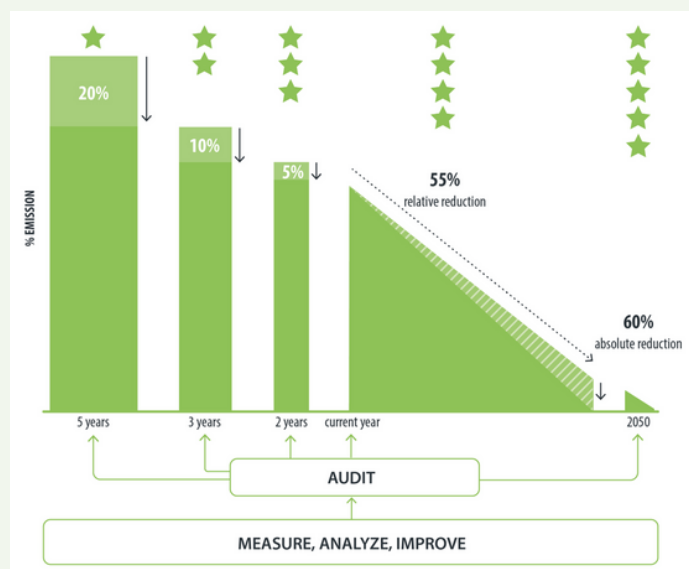
